This is to inform that, the students who got promoted to II year (i.e.. students admitted during the academic Session July, 2019), III year (i.e. students admitted UG & MBA Courses during the academic year 2016-17 and 2017-18 batches) have to pay the prescribe term fee, as mentioned against their respective course admitted, as detailed hereunder :

**Note:** The students who are not yet paid their II year (i.e. students admitted prior to the academic year 2019-20) / III year (i.e. students admitted prior to the academic year 2016-17) can pay their prescribed term fee with a fine of Rs.500/- (Rupees five hundred only).

The Last date for payment of II & III year term fee is as detailed below :

- (i) Without fine - from 05.07.2021 (Monday) to 04.08.2021 (Wednesday)  
and  
(ii) With a fine of Rs.200/- - from 05.08.2021 (Thursday) to 20.08.2021 (Friday).

The fee should be paid by way of D Challan, which can be downloaded from the DDE website [www.svudde.in](http://www.svudde.in) payable at Andhra Bank / State Bank of India, S.V. University Branch, Tirupati. The Original Challan (Remitter's Copy) should be sent to the O/o the Director, Directorate of Distance Education, S.V. University, Tirupati, by duly furnishing the details viz., Name of the Student, Course Admitted, Admission No. and Nature of Fee on the back side of the Challan.

Further, the Students, who got admitted in M.B.A., M.Sc. – Chemistry and M.A. – Political Science & Public Administration, Telugu and Hindi courses, have to mention the Elective / Optional papers chosen, along with the above details.

The study material pertaining to II & III year will be issued, after receipt of the above prescribed course fee.
